MISSION STATEMENT LEARNING TO CARE, CARING TO LEARN

St Columba's is an inclusive school which provides a broad and balanced curriculum to ensure all pupils achieve their potential, personally, socially, emotionally and academically in all areas of the curriculum, (Regardless of gender, ethnicity, religion, sexual identity, physical ability or educational needs). When planning, teachers set suitable learning challenges and respond to learner's diverse learning needs.

"St Columba's Catholic Primary school is a community which reflects and celebrates the diversity of God's kingdom. Each individual is of value and all can learn from one another."

Some learners have a special need: Communication and Interaction (Autistic Spectrum Conditions, Speech and Language and Communication Needs), Cognition and Learning (Moderate Learning Needs, Specific Learning Difficulties), Behavioural, Social and Emotional needs, Sensory and Physical Difficulties (Hearing Impairment, Visual Impairment, Multisensory Impairment and Physical Difficulties) that could create a barrier to learning. At St Columba's we aim to make provision, where necessary, to support individuals or groups of learners working in partnership with others when required. This enables all learners to participate effectively in the full curriculum of the school.

Learners may have a Special Educational Need or disability either throughout, or at any time, during their school career. This policy and offer ensures that curriculum planning, including the wider curriculum (the whole experience a learner encounters including homework, lunchtimes, after school activities, external visitors etc.) and assessment for learners with SEND takes account of the type and extent of the difficulty experienced by the learner.

At St Columba's we aim to:

Identify children with Special Educational Needs as early as possible.

Enable children with SEN to have a broad, balanced and relevant curriculum which is differentiated to meet their individual needs.

Ensure that appropriate and relevant provisions are made.

Ensure a positive working partnership with parents.

Ascertain the views and wishes of the child and encourage participation in all the decision- making process.

In order to achieve this we implement a graduated approach based on the [guidance from Bradford Metropolitan District Council's Children's Services for SEN](#). This is based on an Assess-Plan-Do-Review 3 range structure.

If a child has a Statement of Special Educational Needs or and Education, Health and Care Plan, then we provide the support detailed in the plan.

Our offer at Ranges 1 to 3 for each area of SEND is described below. Please be aware that provisions are individualised to learner's needs and put in place at different stages of their development. Learners may access one or more of these provisions described but not necessarily all of them.

Children in school will get support that is specific to their individual need. This may be all provided by the class teacher or may involve:

- Other staff in school
- Staff who will visit the school from the Local Authority central services such as ASD Team
- Staff who visit from outside agencies such as Speech and Language Therapy (SALT) service.
