Public Sector Equality Duty

It also ensures that we continue to tackle issues of disadvantage and underachievement of different groups.

Information on pupils by protected characteristics

Protected Characteristics. The Equality Act covers the same groups that were protected by existing equality legislation – age, disability, gender reassignment, race, religion or belief, sex, sexual orientation, marriage and civil partnership and pregnancy and maternity. These are now called '**protected characteristics**'. Every person has several of the protected characteristics, so the Act protects everyone against unfair treatment. In order to ensure that all pupils are protected from discrimination, the school collects information on protected characteristics.
